



# Wisconsin Parental Choice Program

2026-27

Aquinas Catholic Schools is a participant in the Wisconsin Parental Choice Program (WPCP). Under this program, parents have a voice in how their tax dollars are spent on the education of their children. This income-based K4-12 program provides parents the choice to send their children to a private or chartered school tuition-free. For those eligible students selected to the WPCP, the family receives a voucher from the State of Wisconsin that pays their student's ACS tuition and other school fees in full.

## What is the Wisconsin Parental Choice Program?

The Wisconsin Parental Choice Program (WPCP) allows students who reside in a Wisconsin School district to attend any participating private school tuition-free if financial and residential criteria are met and the students are selected by the Department of Public Instruction (DPI). The private school, on behalf of the student's parent or guardian, receives a state aid payment (voucher) for each eligible student. WPCP is a separate application process from the ACS tuition assistance application through FACTS.

## How do I know if we are eligible?

You must first be a resident of the State of Wisconsin. Families also must meet income and student eligibility requirements.

### Income Eligibility:

- The prior year adjusted gross income (AGI) must be at or below 220% of the federal poverty guideline (see chart).

The stated limits would include income of parents or legal guardians residing in the same household as the student applicant. Family size includes parents or legal guardians and their children by birth, marriage, or adoption residing in the same household as the student applicant.

\*2025 Income can be used to qualify if you apply for the WPCP prior to filing your 2026 taxes.

### Student Eligibility:

- Students NEW to Aquinas Catholic Schools, coming from a public school or home school entering grades K4 through Grade 12, are eligible.
- Returning ACS students entering Grades K4, K5, 1, and 9 are eligible.

## What expenses are covered by the WPCP vouchers?

The WPCP provides private schools with state-funded vouchers that cover full tuition, enrollment fees and books. WPCP vouchers do not cover co-curricular activities, equipment, transportation, after-school or summer care, elective school trips, classroom supplies, or meals.

Parents MUST complete the [online Private School Choice Program](#) application during the open application period of February 2, 2026 through September 14, 2026 at <https://sms.dpi.wi.gov/ChoiceParent/>. An email address is required to apply. In addition, parents must provide

supporting documentation directly to the ACS Finance office within the application period. The State of Wisconsin will not accept late applications for any reason.

## What supporting documentation is required to complete the application?

- **Proof of income:** Required for all students NEW to WPCP. Documentation required will be based on the income determination method you select in your online application; *DPI (Dept. of Instruction) method, or DOR (Dept. of Revenue) method*. Please refer to the state's information [before](#) selecting the income determination method: [DPI Frequently Asked Questions for Parents](#)
- **Proof of residency:** Required for all new and returning applicants. For a complete list of acceptable forms, refer to the DPI website. Recommended documents: Water, Gas, Electric bills, Wage statements or W2 Year-End earnings statement. All supporting documentation must be submitted to the ACS Finance office during the application period beginning Feb. 3 but no later than 4:00 p.m. on Apr. 17, 2025.

## Do I need to reapply for WPCP every year if my child receives a voucher at Aquinas Catholic Schools?

**YES!** You must reapply each year online via the DPI website and supply residency documentation during the open application period. Students who have received a Choice voucher and reapply will be awarded a voucher each subsequent year regardless of income and grade.

## What if my income increases in subsequent years?

Once your student is awarded a voucher to attend ACS, he or she is eligible to stay in the program each year through grade 12. The “once in/always in” provision means your student remains voucher eligible even if family income rises. Family income is determined for students in the year they [enter](#) the program. Wisconsin residency requirements must still be verified each year.
